Rev Beth: The Safe Congregation Response Team is a "checklist" approach to situations, whereas Healthy Congregation is a program that looks at the congregation as a system with healthy behaviors by trained facilitators. It is a long-term shift in behaviors; it is intentional and hard work with different expectations and outcomes. My husband is on the HC Board in Ohio currently training ministers. It's not impossible to be joint Safe/Healthy committee. The first step is to train the team, so the launch of the HC team comes later on.
